## **MEMORANDUM OF UNDERSTANDING**

**Between**

**Marmara University, Türkiye**

**&**

**The Public Conservatory of Music "Domenico Cimarosa", Italy**

Marmara University, Türkiye and The Public Conservatory of Music "Domenico Cimarosa" Italy recognising the benefits to their respective institutions from the establishment of international link, conclude this Memorandum of Understanding (MOU).

1. The purpose of this MOU is to develop academic and educational co-operation and to promote mutual understanding between two academic institutions.
2. This MOU signifies a statement of intent to collaborate, but is not a legally binding document.
3. The two academic institutions agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.
  - 3.1. Exchange of faculty and administrative staff.
  - 3.2. Exchange of graduate and undergraduate students
  - 3.3. Conducting collaborative research projects
  - 3.4. Conducting lectures and organising symposia
  - 3.5. Exchange of academic information and materials
  - 3.6. Promoting collaboration in fields of mutual interest
  - 3.7. Promoting other academic co-operation as mutually agreed
4. The exchange students shall not pay academic fee at the host institution. The period of exchange is one semester.
5. The development and implementation of specific activities based on this MoU will be separately negotiated and agreed by two institutions. Both institutions agree to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.

6. Marmara University and The Public Conservatory of Music “Domenico Cimarosa” recognize the value of this Memorandum of Understanding to each other in promoting their programmes and activities, but any promotional material/activity which include reference to concerned countries must be sent to and be approved by the representatives of the institutions before use and print.
7. It is understood that the implementation of any type of co-operation stated shall depend upon the availability of resources and financial support at the institutions concerned.
8. Should the collaborative research activities under the MOU result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
9. This MOU may be amended or modified by a written agreement signed by the representatives of both institutions.
10. This MOU shall become effective upon being signed by the representative of each party and shall remain effective for a period of five years. This MOU may be terminated by one of the parties upon written notice to the other party not later than ninety days before the termination date. The termination will not affect ongoing activities.
11. Both institutions agree that any controversies, disputes or claims arising out of this MOU shall be settled by means of consensual negotiation.
